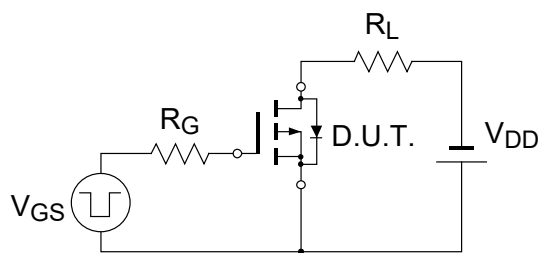


Waveform

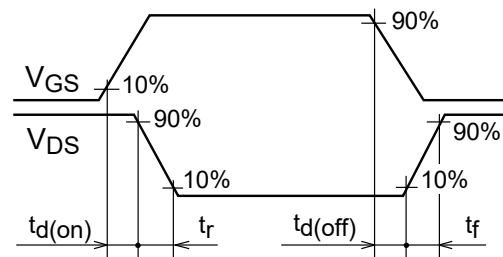


Switching Time

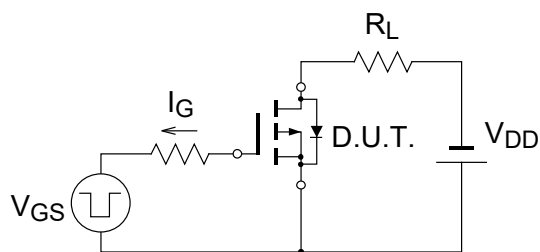

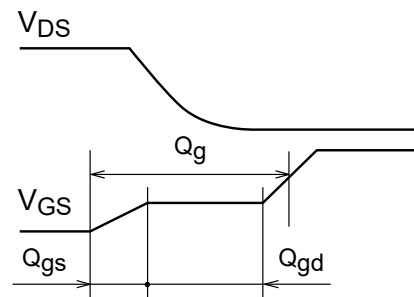


Gate Charge

Test Circuit

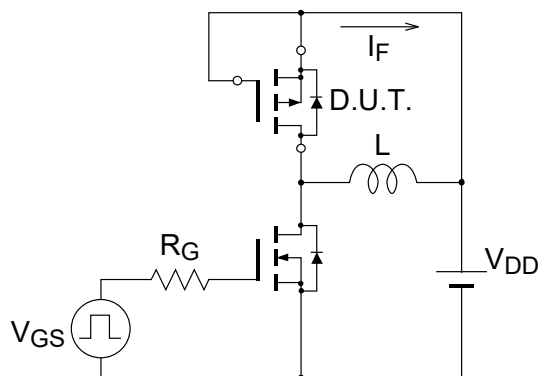

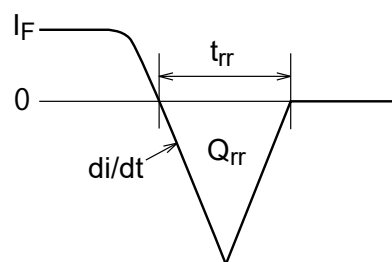

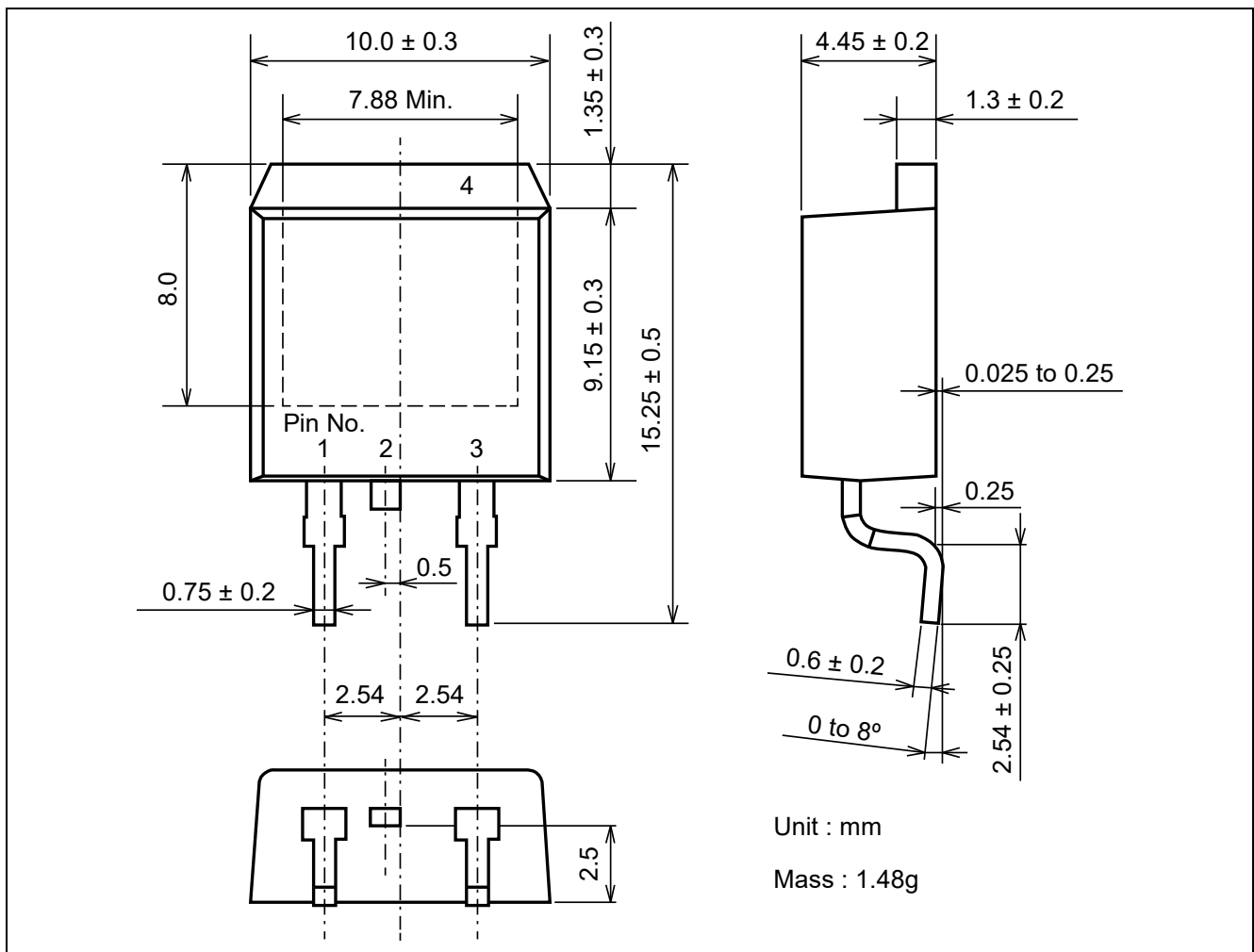
