


Figure 1. Total Capacitance




Figure 2. Forward Voltage vs. Ambient Temperature




Figure 3. Power Derating Curve




Figure 4. Reverse Current vs. Reverse Voltage





Figure 5. Reverse Voltage vs. Reverse Current
