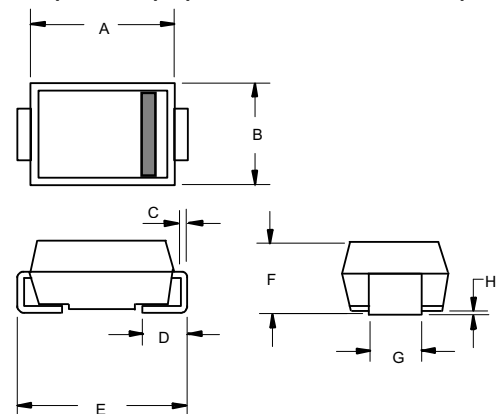

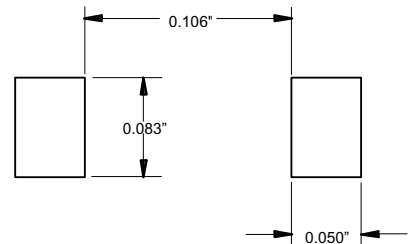

SUGGESTED SOLDER PAD LAYOUT

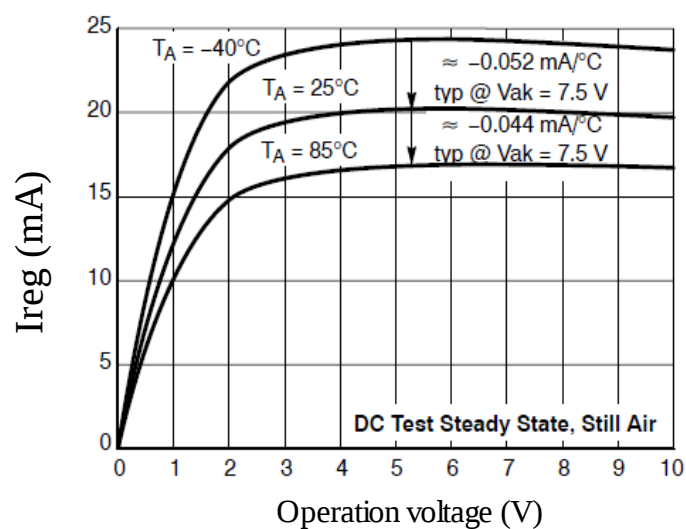
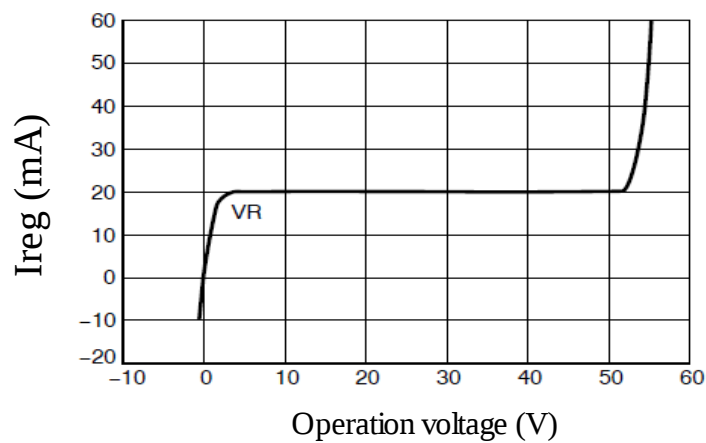

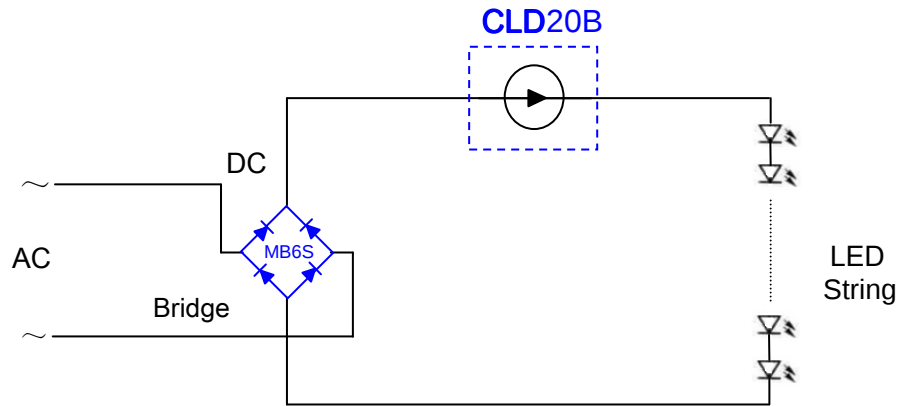

Type Application Circuit
(20mA each LED String)

Number of LED's that can be connected is determined by:

$$\text{LEDs} = (\text{Vdc} - \text{Vak}) / \text{LED } V_F$$

Example: $V_{ac}=110V$, CLD $V_{ak}=45V$, LED $V_F=3.5V@20mA$

Using our [P/N:MB6S](#) bridge for whole wave rectifier

After rectifier, Output $V_{dc}=150V$

$(150V_{dc} - 45V_{dc}) / 3.5V_{dc} = 30$ LEDs in series.
