

Description

Characterized by a very low reverse Capacitance the PIN Diode BAR63V-06W was designed for RF signal tuning. As a function of the forward bias current the forward resistance (rf) can be adjusted to less than 1 Ω while the low reverse capacitance offers a high isolation. Typical applications for this PIN Diode are wireless, mobile and TV-systems.






Figure 1. Forward Resistance vs. Forward Current




Figure 3. Forward Current vs. Forward Voltage




Figure 2. Diode Capacitance vs. Reverse Voltage




Figure 4. Reverse Voltage vs. Reverse Current





Figure 5. Typical Charge Recovery Curve
