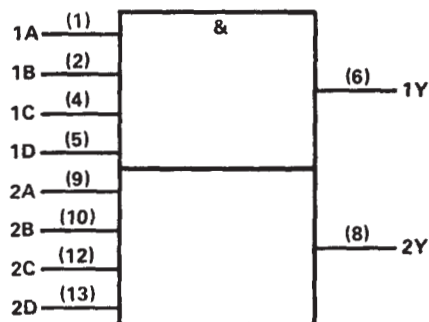

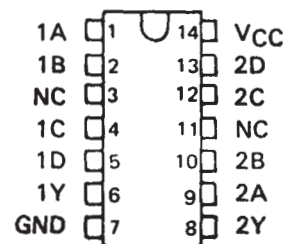

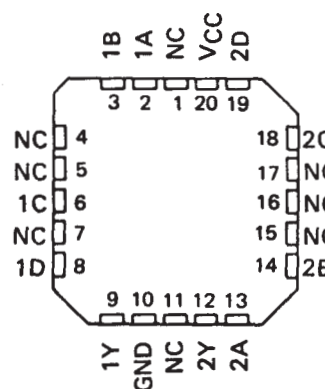

(TOP VIEW)

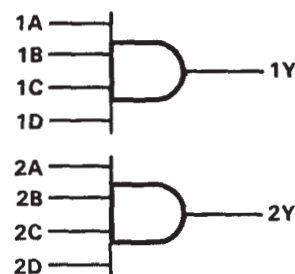


SN54LS21 . . . FK PACKAGE

logic diagram

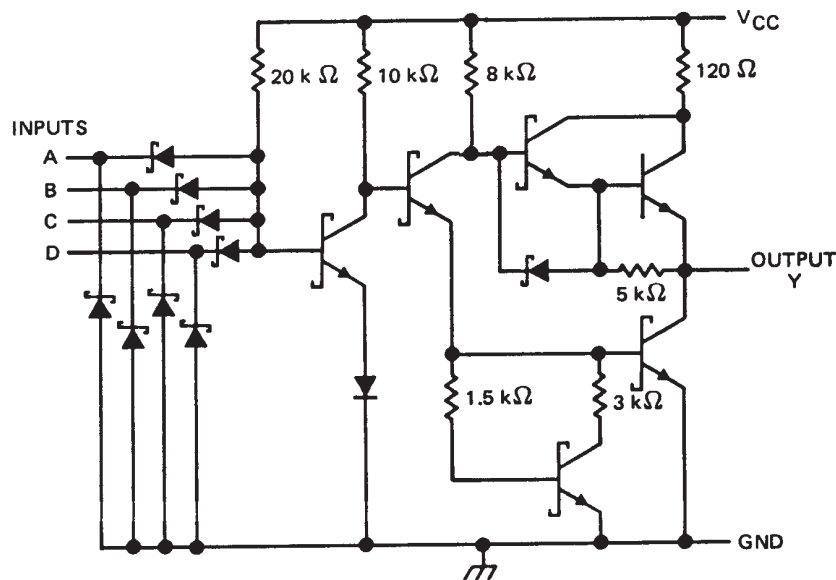

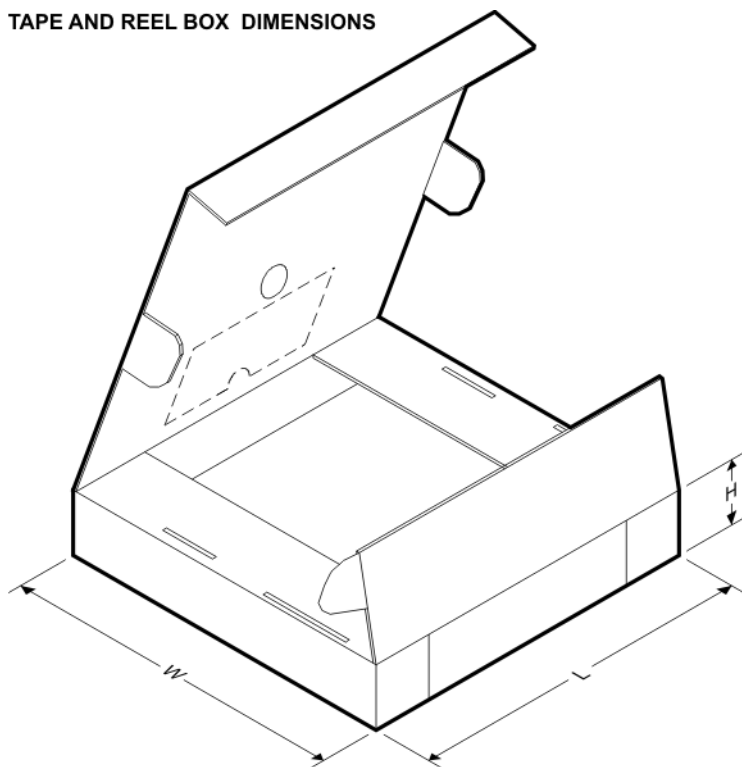

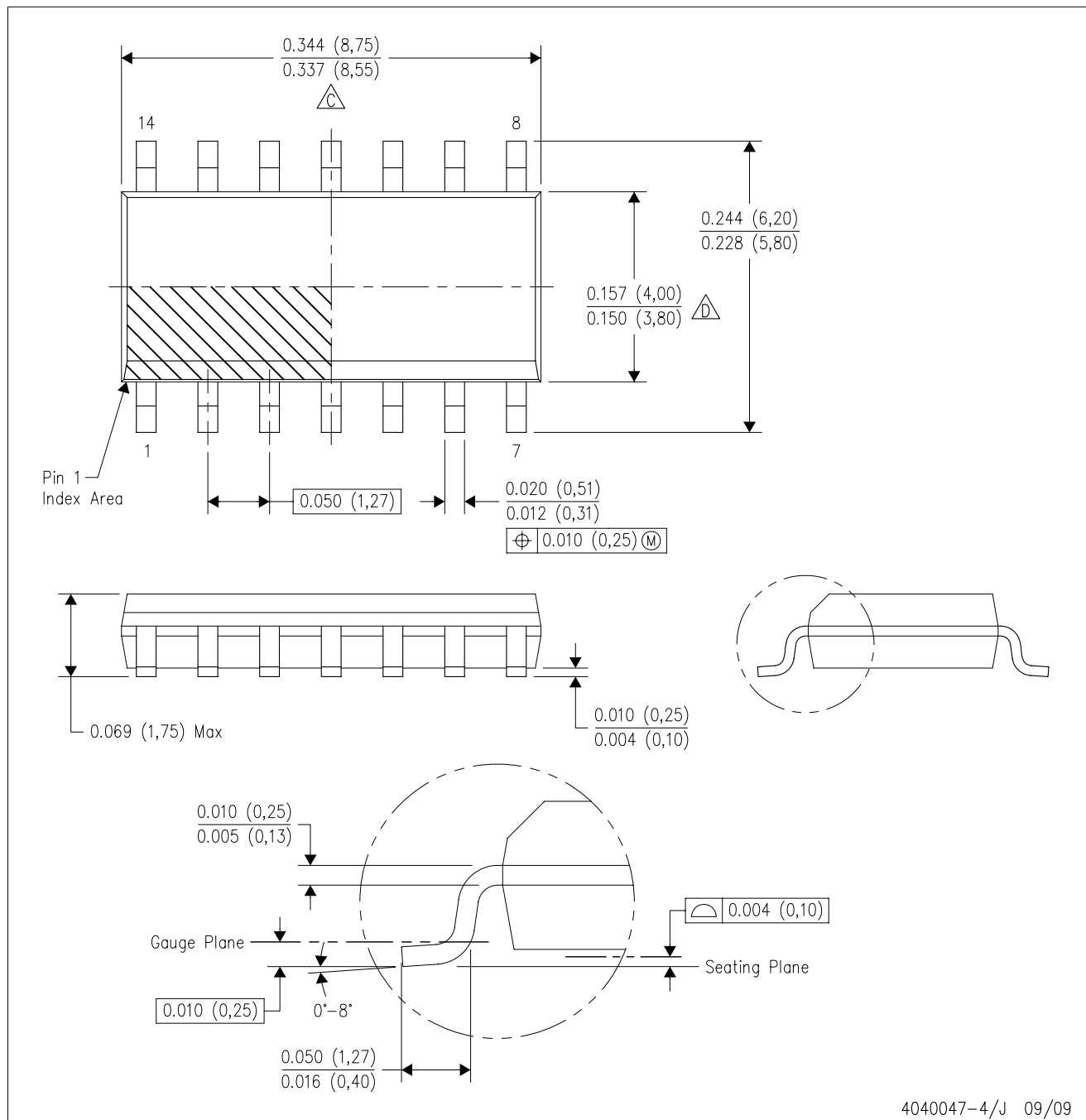
