1. General description

The 74ABT16245B is a 16-bit transceiver with 3-state outputs. The device can be used as two 8-bit transceivers or one 16-bit transceiver. The device features two output enables ($1\bar{O}E$ and $2\bar{O}E$) each controlling eight outputs, and two send/receive (1DIR and 2DIR) inputs for direction control. A HIGH on $n\bar{O}E$ causes the outputs to assume a high-impedance OFF-state. This device is fully specified for partial power down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.




Fig. 1. Logic symbol





Fig. 2. IEC logic symbol





V_{OL} and V_{OH} are typical voltage output levels that occur with the output load.


Fig. 3. Input (nAn) to output (nBn) propagation delay times



Fig. 5. Test circuit for measuring switching times




