


Fig.1 Ground Emitter Propagation Characteristics




Fig.2 Grounded Emitter Output Characteristics




Fig.3 DC Current Gain vs. Collector Current (I)





Fig.4 DC Current Gain vs. Collector Current (II)

Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current( $I$ )




Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current( $II$ )




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current ( $I$ )






Fig.8 Collector Output Capacitance vs. Collector-Base Voltage  
Emitter Input Capacitance vs. Emitter-Base Voltage







