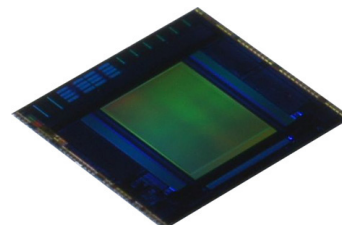

The Toshiba T8EX2 is a color sensor chip which includes area color image sensor embedded with image signal processor (ISP).

In the sensor area 1200 vertical and 1600 horizontal signal pixels, and the image size meets with 1/5 inch optical Format. Use of the CMOS process enables low power consumption operations. It also provides excellent color reproduction through its primary color filter, and embedded image signal processor without CPU enables small and simple camera system. So it is fit to use as an image input device for phone cameras.

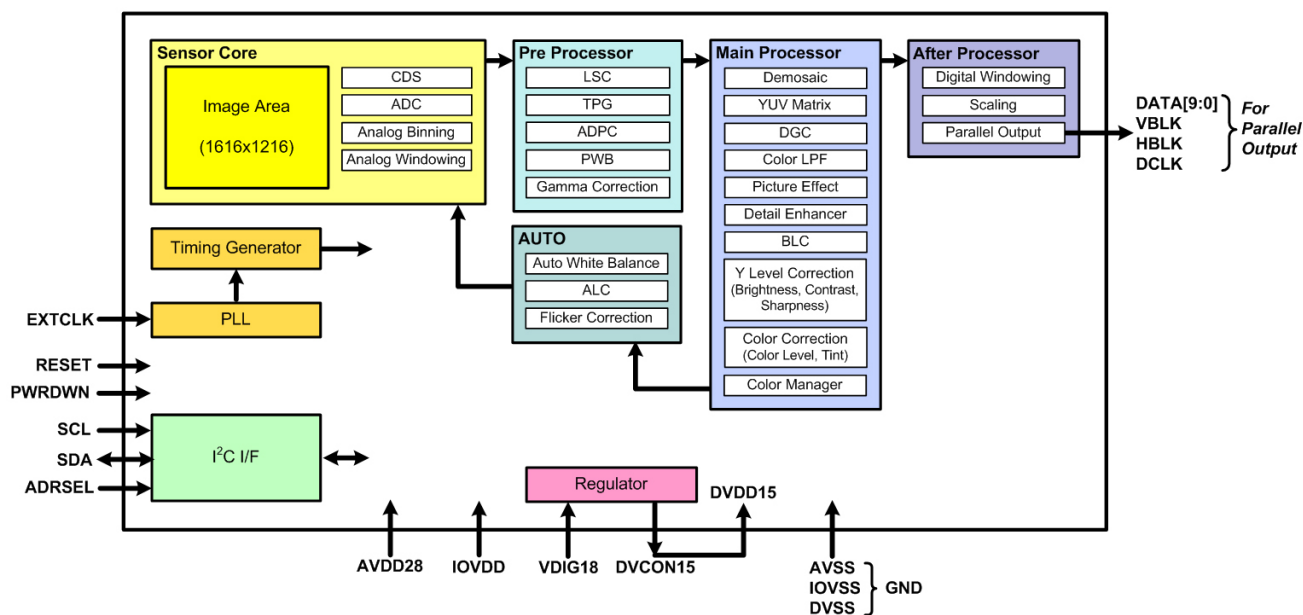
