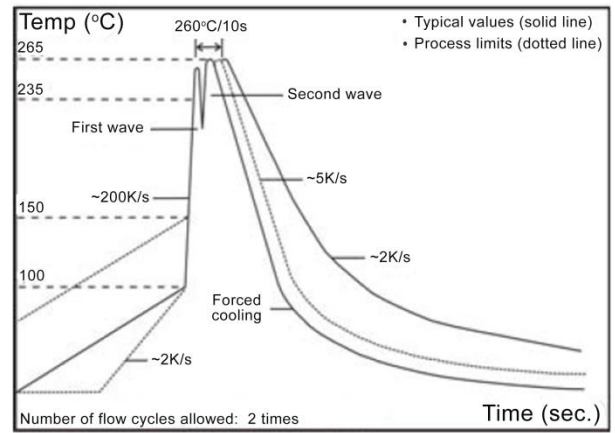
Power Derating Curve:



Soldering Condition:



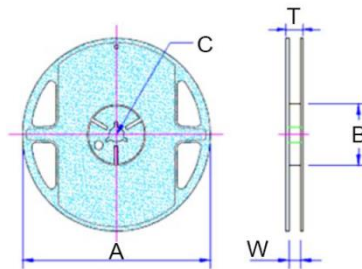
IR Reflow Soldering
