



simplified diagram in ESD machine


IEC61000-4-2 Waveform



oscilloscope

1. Set up ESD Tester at IEC61000-4-2 condition.  
(IEC61000-4-2 :  $C=150\text{pF}$ ,  $R=330\Omega$ )
2. Mount a sample on the high frequency test board with the SMA connector.
3. Connect the SMA connector to the oscilloscope by  $50\Omega$ cable.  
Then, add the 10X-attenuator between test board and the cable to protect the oscilloscope.
4. Discharge ESD in contact discharge mode at any voltage.  
(normally 8kV Max.)


## ● Dimensions (SOD-123FL SC-109B PMDU)
