C Schematic:



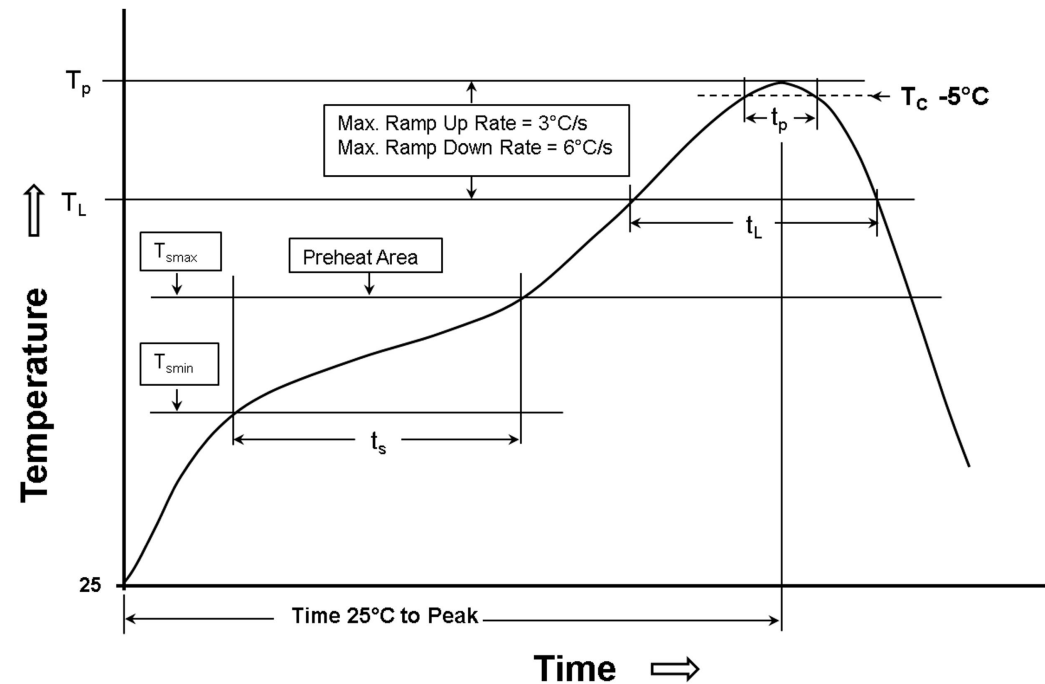

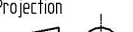
