



Fig. 1. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values




Fig. 3. Forward current as a function of forward voltage; typical values

 $(5) T_i = -40 ^{\circ}C$




Fig. 5. Diode capacitance as a function of reverse voltage; typical values






Fig. 4. Reverse current as a function of reverse voltage; typical values





Average reverse power dissipation as a function of reverse voltage; typical values








