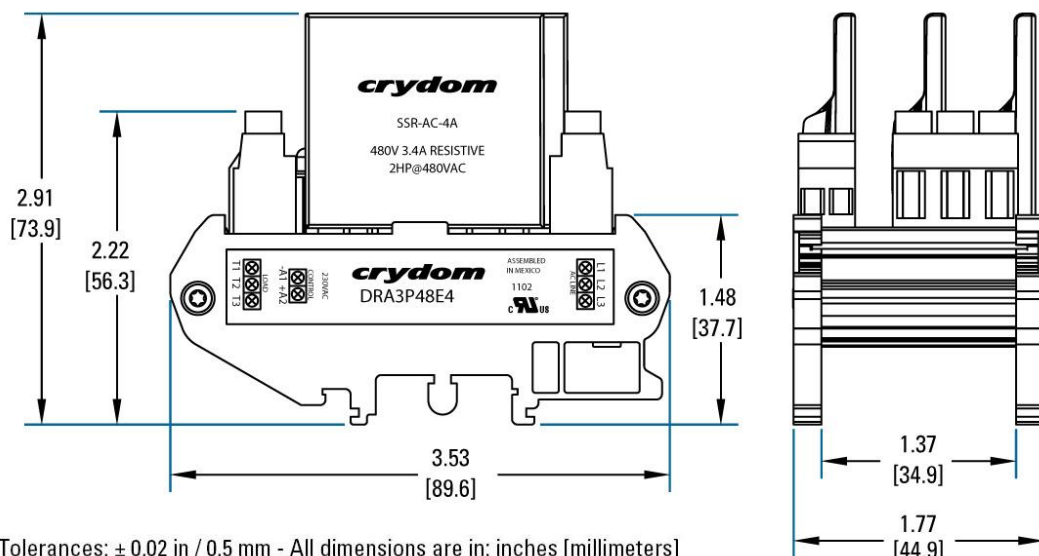

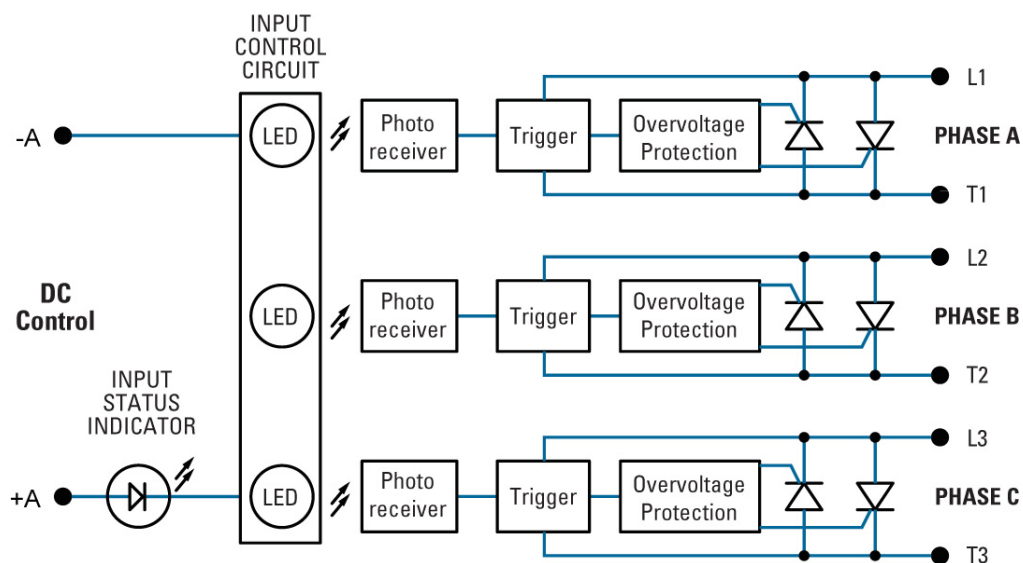

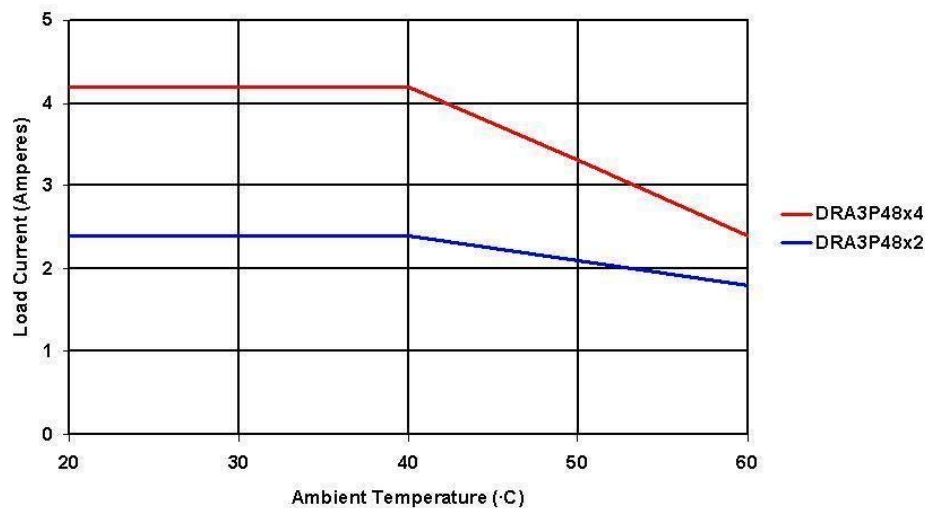


WIRING DIAGRAM
