
1. Applications

2. Features

- (1) Small footprint due to small and thin package
- (2) Low drain-source on-resistance: $R_{DS(ON)} = 39 \text{ m}\Omega$ (typ.) ($V_{GS} = -10 \text{ V}$)
- (3) Low leakage current: $I_{DSS} = -10 \mu A \text{ (max) (V}_{DS} = -40 \text{ V)}$
- (4) Enhancement mode: V_{th} = -0.8 to -2.0 V (V_{DS} = -10 V, I_D = -0.1 mA)






Fig. 5.1 Device Mounted on a Glass-Epoxy Board (a)




Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking





Fig. 8.1 $I_D - V_{DS}$




Fig. 8.3 I_D - V_{GS}




Fig. 8.4 V_{DS} - V_{GS}




Fig. 8.5 R_{DS(ON)} - I_D




Fig. 8.6 R_{DS(ON)} - T_a




Fig. 8.7 IDR - VDS




Fig. 8.9 Vth - Ta




Fig. 8.11 P_D - T_a (Guaranteed Maximum)




Fig. 8.8 Capacitance - V_{DS}




Fig. 8.10 Dynamic Input/Output Characteristics




Fig. 8.12 r_{th} - t_w (Guaranteed Maximum)





Fig. 8.13 Safe Operating Area (Guaranteed Maximum)
