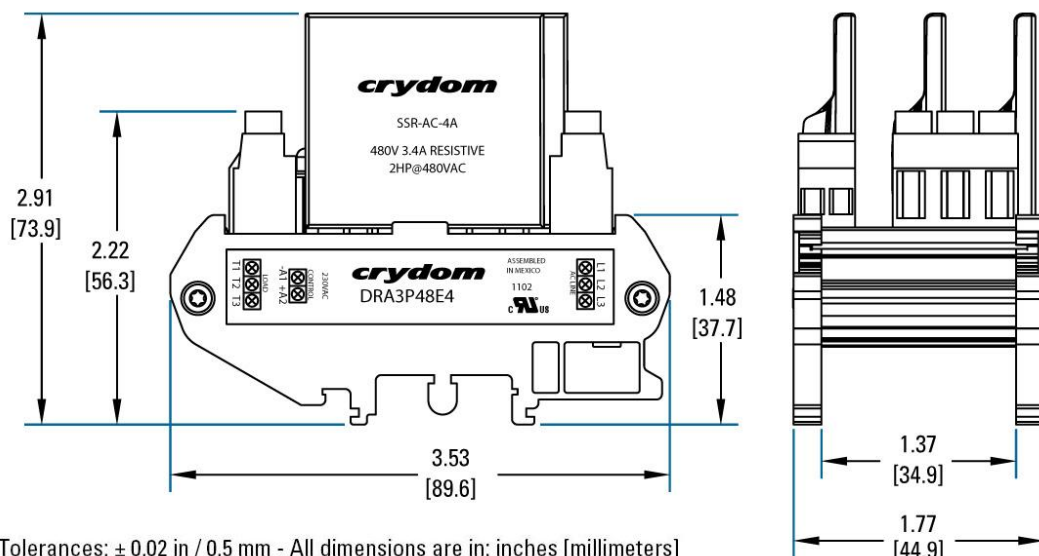

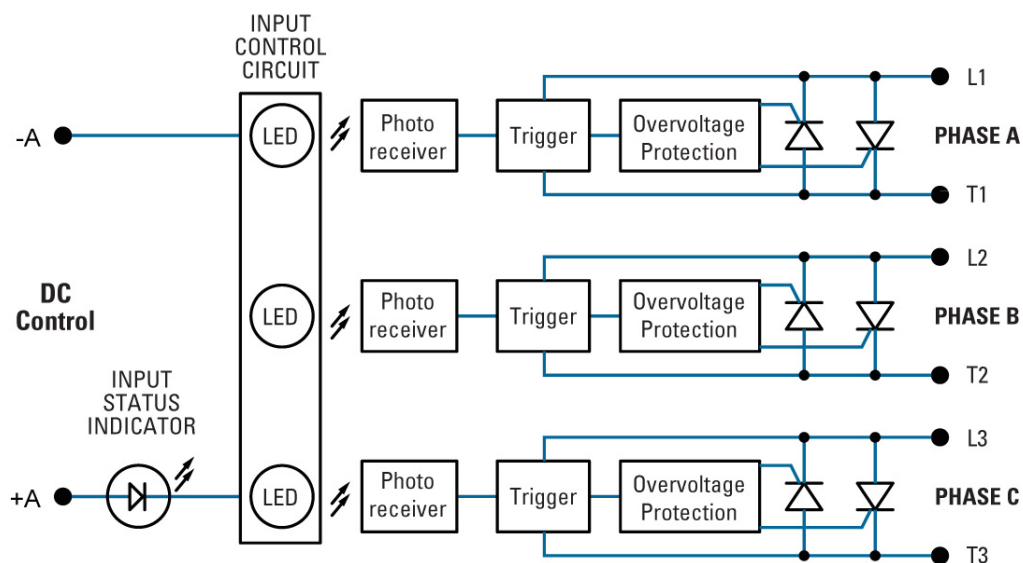

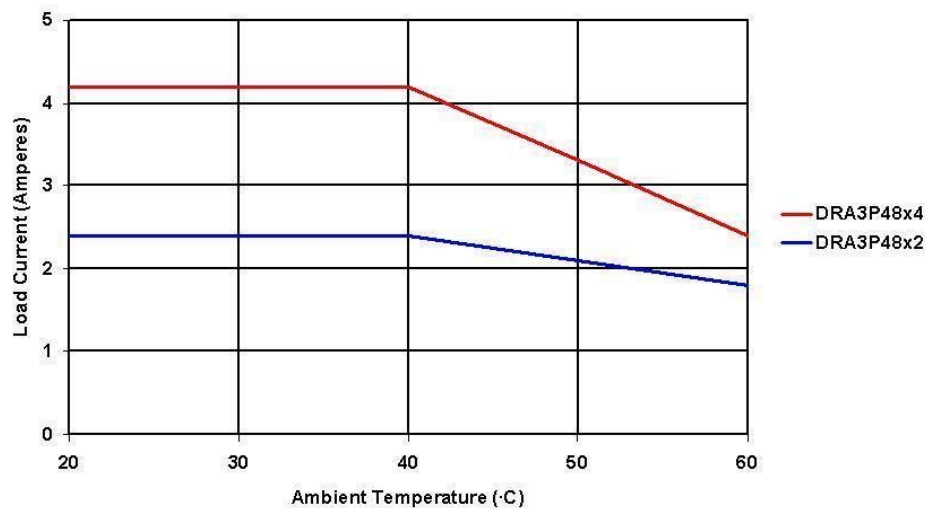


WIRING DIAGRAM
