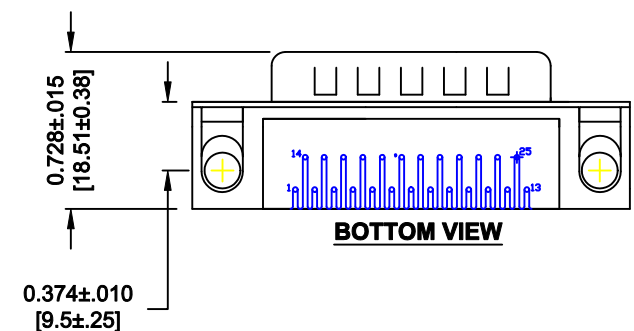
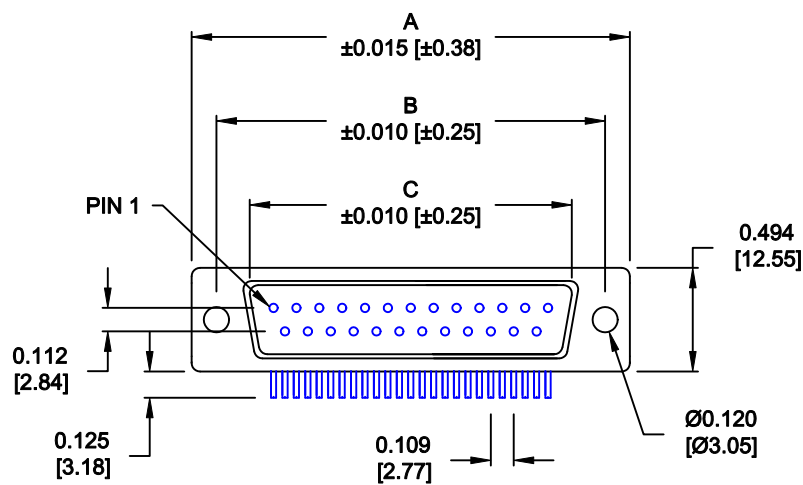

BOTTOM VIEW

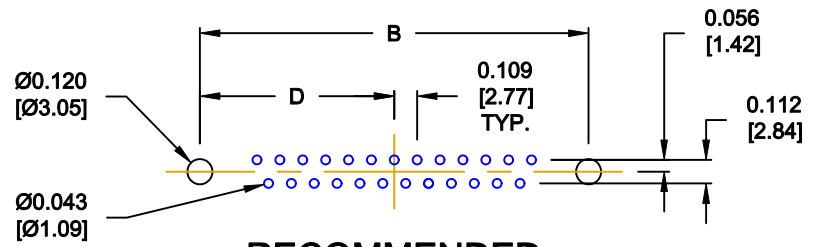
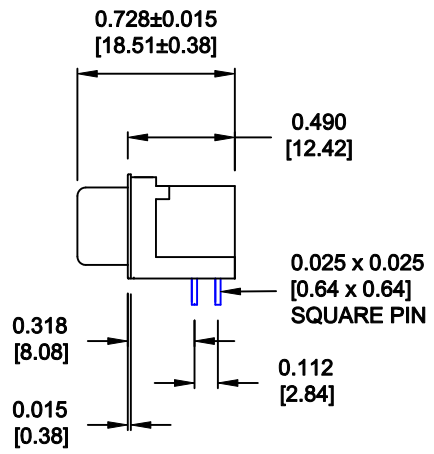
