



Fig.1 Ground Emitter Propagation Characteristics




Fig.2 Typical Output Characteristics




Fig.3 DC Current Gain vs. Collector Current( $I$ )









Fig.4 DC current gain vs. output current (II)

Collector-Base Voltage






Fig.10 Safe Operating Area
