





F1 Typical Inductance vs. Current Characteristics:




F2 Typical Inductance vs. Frequency Characteristics:





F4 Typical Temperature Rise vs. Current Characteristics:



If the product is potted in customer applications, the potting material might shrink during and after hardening. The product is exposed to the pressure of the potting material with the effect that the core, wire and termination is possibly damaged by this pressure and so the electrical as well as the mechanical characteristics are endangered to be affected. After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

Cleaning agents that are used to clean the customer application might damage or change the characteristics of the component, body, pins or termination.

- •Reflow soldering is not applicable. Wave soldering is recommended.
- •All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't be quaranteed.
- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
- Due to heavy weight of the component, strong forces and high accelerations might have the effect to damage the electrical connection or to harm the circuit board and will void the warranty.
